Dear Mr. Dulberg:

We have received your letter of complaint regarding attorneys George Flynn, Ronald Barch, Parry Accardo and Shoshan Reddington.

As you may know, the duties of this Commission relate primarily to investigating and prosecuting allegations of professional misconduct against attorneys. When we have sufficient evidence of serious misconduct by an attorney, we may initiate proceedings seeking disciplinary sanctions against the lawyer, such as suspension or disbarment from the practice of law. However, we are unable to intervene in, review or impact legal matters which were, are or may be the subject of court proceedings.

From the information you have provided, there is not a sufficient basis for this agency to investigate or pursue charges of professional misconduct against any of the above-named attorneys at this time. It is not unusual for parties in court cases to maintain that the opposing lawyer has made false factual and legal assertions or adduced or presented false evidence. This circumstance does not in itself justify a disciplinary investigation into the professional conduct of the opposing lawyer. Issues regarding the truth and legitimacy of claims made and evidence offered in court proceedings are appropriately addressed and resolved in the courts rather than through the lawyer disciplinary process.

For the foregoing reasons, we will take no action with respect to your complaints against attorney Flynn, Barch, Accardo and Reddington.

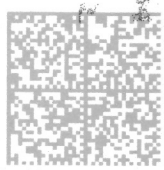
