In the <u>ARDC Complaint against Balke</u>, points 37 through 41 make it appear that Dulberg is to pay "\$0" for the case file which would appear to match Balke's book keeping ledger provided in his response.

The following email where the discussion continued shows that something else took place:

On Friday, July 10, 2015 Brad J. Balke met with Paul and Barbara Dulberg just before court and a discussion over the costs and release of lien took place. During the conversation Mr Balke told Dulberg that he could not release the case file or lift the lien because Mr Balke had paid Thomas J. Popovich and Hans Mast 1/2 the costs in the case to get the case file. Barbara Dulberg immediately wrote Balke a check in the amount of \$1,539.32, the exact amount that Balke had previously paid to Popovich and Mast. Balke then grabbed a blank court order form from inside the courtroom and wrote a release of lien, signed and dated it and handed it to Dulberg. Balke told Dulberg to contact him after the weekend and Balke would give Dulberg instructions on when and where the case file would be available to pick up.

After giving Balke the check and receiving the lien release Dulberg pursued the matter of the case file starting on Monday, July 13, 2015:

On July 15, 2015 the check that Barbara Dulberg wrote and handed to Balke was posted to her bank account as cashed. Mr Balke had received the exact amount of money he had invested in the case file and replied to Dulberg's requests:

The case file will be available at Donahue's office after 1pm today.

On July 16, 2015 Dulberg emailed Balke confirming that Dulberg had received the case file:

Balke was paid in full for his costs in the case, signed a lien release and turned over his case file in July of 2015.

Why would Balke then accept a check for those same costs from the bankrutcy trustee (page 4 in the link) in Febuary of 2017. (see "Brad J. Balke, P.C. Customer Quick Report January 1, 2015 through March 21, 2024" found in his response) while claiming "I have no record of payment from the trustee for expenses, and not sure why or if ever a trustee would make such a payment."

Why then is only the Febuary 2017 bankruptcy trustees check recorded in Balke's ledgers found in his response while not understanding why the trustee would make such a payment?

All the documents I have on Mr Balke are attahed to this letter. These documents were all disclosed during discovery in 17LA377 starting in May 2019.

In this PDF on pages 4-9, 11-20 we believe are particularly helpful in rebuking Mr Balke's response because they give a true accounting (checks included) of what Mr Balke paid Mr Mast and Mr Popovich back in 2015.

The July 2015 cashed check written against Barbara Dulbergs account proves Balke received the exact amount of what Balke paid out to Popovich and Mast in March of 2015.

The Bankruptcy courts records provided by the trustee also proves that Balke was sent and cashed a check for the exact same amount that Balke previously received directly from Paul and Barbara Dulberg in July 2015

Bottom line is we have undeniable factual proof that it is Mr. Balke and his ledgers that are mistaken and that Mr Balke did receive double what he paid out to Mast and Popovich in costs.

In addition, note the emails and letter on pages 4-9 of this PDF where Mast and Balke the trade cases (Paul Dulberg for Frank Cavenaugh). Paul Dulberg talked to Frank Cavenaugh about his experience. It appears that Frank Cavenaugh hired the same law firm, Law Offices of Thomas J. Popovich P.C. Dulberg left the Popovich firm and went on to hire Brad Balke but Cavenaugh never hired Balke. If the ARDC would interview Cavenaugh as Dulberg did they would learn that Frank Cavenaugh also had Hans Mast handling his case at the Popovich firm. Tom Popovich explained to Cavenaugh that he had to pull Mast off the Cavanaugh case to work on another case and that Brad Balke would be taking over representation. (But Brad Balke is not an employee of the Law Offices of Thomas J. Popovich P.C. and Brad Balke never filed an appearance in the Cavanaugh case and Tom Popovich never withdrew his appearance.) Cavanaugh was under the impression that Balke worked for Popovich and that Balke was another one of his attorneys. So, how could Mast trade the Dulberg case for the Cavenaugh case with Brad Balke from another firm if Balke never represented Cavenaugh and Cavenaugh never hired Balke?

It appears that Balke presented himself as an employee of Popovich to Cavanaugh. This is what Cavanaugh told Dulberg.

It also appears in the Circuit Court Clerks file that Mr Cavenaugh was only represented by the Popovich firm and was never represented by Balke.

Makes one question how the Cavenaugh case could be traded by Balke to anyone.

Please note how Balke was the second consecutive retained attorney (after Popovich and Mast) that tried to cap the value of the remainder of case 12LA178 at \$55,000 or less in violation of the Federal bankruptcy automatic stay and without informing the bankruptcy court. This is described in detail in the video series on The Burial of Bankruptcy.


