Members of the ARDC Committee,

This complaint explains in detail the main techniques Illinois attorneys Edward X. Clinton and Julia C. Williams used to suppress the release of discovery documents of their own permanently disabled client without their client knowing. Clinton and Williams used quite sophisticated methods of document and information suppression in attempts to undermine and destroy the valid claims of their own handicapped client.

Chapter 1 describes how Clinton, Williams and the defense counsel suppressed documents and information.

Chapter 2 shows how these document and information suppression techniques were then used to create confusion and vulnerability in their own client's case in at least 10 different ways (labeled A through J).

The methods Clinton and Williams used are carefully coordinated with one another and can be said to constitute a system of document and information suppression. In simple terms, this method of large-scale document and information suppression is used to destroy the claims of ones own client by gaslighting ones own client over and over again as can be verified in this complaint.

The people against whom these acts were done would like to state, in simple laymans terms, that attorneys in the Illinois Bar have access to sensitive information of their clients and these attorneys act in a position of trust similar to that of a medical doctor. If a medical doctor used their position of trust, knowledge, skill, privilege, and membership in the AMA to basically drug and rape certain clients, we would all be able to see such behavior as a serious breach of social trust and if how they acted were publicly known, I believe we could all agree it would be unthinkable to allow them to continue to work as medical doctors.

In parallel, the sabotaging of claims of a permanently disabled client seeking redress for wrongs by using the techniques described in this complaint is stunningly vacuous with respect to any concept of ethics and decency. To allow professional attorneys who act in these ways to continue to practice as attorneys in Illinois, while knowing the techniques of deception they have used on at least one of their own (handicapped) clients, is to allow stealth predators to feed on the general population as prey while using their membership in the Illinois Bar as cover.

If Clinton and Williams are allowed to act toward one of their own clients using the sophisticated system of document and information suppression described in this complaint, then the said client could have easily been you, or your parents, or your children, your friends or neighbors. The techniques of deception described here show attorneys gaslighting their own permanently disabled client repeatedly, pure and simple. Would you or your relations be able to discover and defend themselves against the secret methods of deception described in detail in this complaint if they were to happen to you? If not, these attorneys should not be allowed to practice law among the general public.

In addition to exhibits this complaint makes use of 11 'Visual Aid' graphics. These are not mere 'pictures'; they are scalable vector graphics and are designed to allow the viewer to zoom in on any portion with great detail. They are used here to help the reader understand, in simple visual ways, how Clinton and Williams suppressed large numbers of documents and the ways they arranged documents in their case file in order to deceive their permanently disabled former client.
