Mr. Dulberg,

The investigations relating to your charges against Mr. Popovich and Mr. Mast (which I handled) have been closed. As a result, there is no ongoing investigative purpose that would be furthered by my sending you this information.

More importantly, the ARDC's ability to release information from concluded investigations is governed by Illinois Supreme Court Rule 766, which provides that those materials are private and confidential and may not be released without an order from the Court or a justice thereof upon a showing that the release is in the interests of justice. Without such an order, the ARDC cannot release any information to you from these concluded investigations.

If you wish to submit a complaint about Mr. Talarico's alleged alteration of your original complaints, you will have to do it using the documents already in your possession.

We are requesting an exact copy of the ARDC Complaints Mr Talarico filed on our behalf. (Edward X. Clinton - No. 2023IN02517, Julia C. Williams - No. 2023IN02518, Hans Mast - No. 2023IN03135 and Thomas Popovich - No. 2023IN03136)

We have recently discovered evidence that Mr Talarico was editing/removing facts from documents filed with the court approximately 18 months before the opposing counsel crafted lies along 7 key features that were previously removed while in Mr Talarico's control.

This forces us to consider the possibility that Mr Talarico may have edited the ARDC complaints we entrusted with him prior to him providing them to you.

Mr Renfroe,

1. Mr Renfroe wrote, "Without such an order, the ARDC cannot release any information to you from these concluded investigations."

We only ask to see the original complaints that Talarico submitted in our name. We wrote the entire complaint in each case. So we are only asking to see a document that we wrote to make sure it wasn't "switched out" or heavily edited by the very people we were complaining against before it arrived to you.

3. Mr Renfroe wrote, "The investigations relating to your charges against Mr. Popovich and Mr. Mast (which I handled) have been closed. As a result, there is no ongoing investigative purpose that would be furthered by my sending you this information."

As we stated, it is more likely than not that Talarico (and friends) heavily edited or switched out the complaint we wrote before it was submitted to the ARDC. The following video described what Talarico did between December 6, 2022 and December 8, 2022:

It is very possible something similar happened between July 24, 2023 and July 27, 2023 just before Talarico claimed to send the ARDC complaint against Clinton and Williams to the ARDC. It is also very possible that something similar happened between August 28, 2023 and September 15, 2023 before Talarico claimed to send the ARDC complaint against Popovich and Mast to the ARDC. If this proves to be true it means that they played a hoax on you and the Illinois Supreme Court as much as they played a hoax on us.

The obvious question is: If the very people we tried to report to the ARDC "switched out" or heavily edited the ARDC complaint that we wrote before it was given to you, how can the ARDC find any investigation based on the "switched out" or heavily edited ARDC complaint to serve as a valid, final conclusion carrying the authority of the Illinois Supreme Court?

Don't you think it is kind of important to verify whether the document that we wrote and that you have on file matches the document that we actually provided to our attorney under explicit instructions to give to the ARDC?

We wrote the entire document. It was submitted on our behalf. The document we submitted to the ARDC has been available online on a public website for months. It is in our power to quickly verify whether the document you have on file matches the document we provided to Talarico to submit to you.

If we wrote the entire document why can't we see it just to check the contents? If the document was heavily edited or "switched out" before it got to the ARDC, why don't you, as the ARDC investigator affected, want to know whether or not you were tricked?
