- b. In 17LA377 Joel D Berg failed to notify plaintiff of Joel D Berg's conflict of interest with the defendant Thomas J. Popovich and his law office known as the Law Offices of Thomas J. - c. Joel D Berg failed to notify plaintiff of Joel D Berg's previous recusals in cases with the defendants Thomas J. Popovich and Defendant's Law Offices of Thomas J. Popovich, P.C. - d. Joel D Berg and Defendant's Law Offices of Thomas J. Popovich, P.C both knew of the personal relationship and recusal issues between them and jointly concealed their knowledge from the plaintiff. - e. Joel D Berg, Thomas A. Meyer and the Chief Judge of the 22nd Judicial Circuit Court jointly failed to request the Supreme Court of Illinois for the assignment of an Out-of-Circuit Judge as they have had to do in other cases involving Defendants Thomas J. Popovich and Defendant's Law Offices of Thomas J. Popovich, P.C. See attached [Group Exhibit 48-Recusals and related cases/](#) (pages [7](#), [8](#), and [13](#))
- f. We have submitted 14 ARDC complaints to date that contain a detailed record of how Dulberg notified State Authorities of the attorney network. All 14 ARDC complaints are available on the web at: <http://www.fraudonthecourt.net/ardc>

In the 14 ARDC complaints Dulberg is providing evidence that the accused attorneys acted as a network. All of Dulberg's legal malpractice attorneys acted as moles and protected the attorneys that came before them from being discovered for committing fraud against Dulberg. They used a sophisticated system of document and information suppression against their own permanently disabled client. The legal malpractice attorneys shielded Popovich, Mast and other PI attorneys from liability after the PI attorneys committed fraud against their client (and against the Court).

The legal malpractice attorneys also acted to shield the personal friendships and recusal issues between Thomas J. Popovich, the Law Offices of Thomas J. Popovich, P.C. and Judges Joel D. Berg and Thomas A. Meyer from discovery.

Due to the intentional violations of Illinois Supreme Court Rule 2.11 by both Thomas A. Meyer (in 12LA178 and 17LA377) and Joel D. Berg (in 17LA377) Dulberg has been deprived of a unbiased court at every court event in the 10 plus years of litigation.
