The clerks public access file is gutted it does not list the 2.5 years of court dates and does not show her name.

Please see if you can access the documents in the attorney portal, if not I can go there and get them off the microfilm backup.

Susan Hutchinson presided over 1990CF000656 PEOPLE VS. DULBERG, PAUL R. For well over a year.

Every person in my family knows her by name because of 1990CF000656 PEOPLE VS. DULBERG, PAUL R.

There were 1/4 and 1/2 page news articles that ran in the Northwest herald after every single court date.

I want an emergency motion filed 1st asking for Hutchinson to remove herself, second that all previous rulings in the Popovich appeal be deemed void due to hutchinsons self recusal issue and third a default in our favor on all issues.

I told you back in February and March when we filed for appeal that Hutchinson could not preside over any case involving me.
