Mr. Talarico:

I am available at 10:00 a.m. on Tuesday.

Since you first advised of the issues you raised last week, I spoke with Julia Williams, and have obtained copies of several hearing transcripts addressing written discovery. In short, Julia and I had an agreement that she would issue discovery to be answered. We agreed that Defendants would not answer the discovery propounded by Gooch. When Popovich and Mast answered discovery, she informed the court that it had been answered. We then moved on and she deposed Mr. Mast.

Ms. Williams had no issues or objections to Mast's and Popovich's responses, besides some questions she had with the document production. We then made arrangements for her to view the physical file at Popovich's office. I met her there, she reviewed the file and her inquiry was satisfied. Defendants relied on Williams' agreement and representations to the court that written discovery had been answered.

With respect to the manner in which Popovich and Mast responded to Williams' document requests, Williams had no objection, given the general nature of the requests. And again, she wrote to me with some issues that she did have, and we resolved the issues. She agreed with my assessment when we spoke last week.

With this background, I do not see what issues need to be resolved at this late date. I plan to ask the court to close f(1) discovery.
