Subject: Barch sent letters missing in POP documents

Dear Mr. Talarico,

I am entering the Barch documents that Clinton subpoenaed into a separate timeline. It is a work in progress and I estimate I'd need another 3 solid uninterrupted weeks to finish.

Unrelated Side notes:

- 1. I got my bank statements today and will be calling the companies that I paid to produce the Dr's depositions tomorrow to see about getting the signatures.
- 2. The Mast sent letters underwent a change in March of 2013. Before a certain date all letters had the path and file name of the digital file, after that date all references to the file name in the letters disappear completely.

These are only the Letters that either Barch or AutoOwners Insurance sent.

This does not include any Letters sent by ACCARDO/ALLSTATE or MAST/POPOVICH. This work still needs to be done

Barch/AutoOwners Insurance appears to have sent at least 48 Letters but this number may grow as I get through more of the documents.

POPOVICH and BARCH both appear to be MISSING the exact same 16 Letters.

BARCH appears to be missing 1 additional Letter probably because it was sent before Barch appeared in the case.

POPOVICH appears to be missing an additional 8 Letters without any explanation.

POPOVICH appears to be missing an additional 4 but these are not addressed To: nor do they show a CC: to POPOVICH/MAST.

This is a work in progress and I still have about 2-3 more solid weeks of checking the Barch Documents and entering them into a timeline so more letters may appear from the subpoenaed Barch Documents but no new letters will show up from the POPOVICH documents. I have not checked these against the DULBERG documents yet.
