The movie showing the hidden objects behind clipping paths was taken from a file with OCR at the end of the file name

The bates numbered files with OCR are files that I ran through adobe acrobat's Optical Character Recognition tool and are the files I use daily because they make a lot of the text searchable.

The first day you asked me to look at Gagnon exhibit 1 I was looking at it in the file with OCR, not the unaltered base file in the Clinton folder.

Today I used the OCR file to mark up pages for the menards receipt, the same way I did back when we first found Gagnon Exhibit 1.

I made todays movie from the same OCR document.

After talking with you on the phone and I told you I was up to page 4, I rebooted my computer into the old operating system again and thought the process to go page by page and thought it best to start with the original Popovich disclosure found in the Clinton case file.

I started to go page by page again and after a good long while I wasn't finding anything so I jumped to POP 001317 and there was nothing there.

After a few minutes of panic, back tracing my steps and double checking everything it occurred to me that I was in the document with OCR when I made the movie and those lines and boxes hidden behind clipping paths are not in the original Popovich document disclosure.

I think those lines and boxes are relics from when I was trying to figure out Gagnon exhibit 1 back in early March of this year.

Yes, I feel like a dunce.

This is the second time I am grateful that I caught my own error.

Sorry I got so excited over nothing again.
