I know it's a hassle but these need to be double checked with what was given over the phone.

I hope to find more in the Dulberg Documents in the near future as well as take the time to match up more court orders with the dates that Thomas J Popovich appeared in court according to the transcripts.

Makes me think, if we have his writing on the court orders for the days the court reporters clearly identify him, Can we use the handwriting on the court orders to fill in some of the unknown speakers and clear up who was in court on which dates?
