I thought I should send this now rather than wait.

I have attached 2 files, one is from Julia Williams Response to the subpoena and the other I found in the Dulberg Master File

Main issue - There is an attachment Flynn sent Williams with his response that is missing from both the Subpoenaed document and the Dulberg Master File document.

* Notes:

- The documents are named identical but they are not identical.
- 1.12700 megabytes size difference (Significant)
- Different created/modified dates and encoding software does not match (Not sure why)
- Title of document is different (Missing RE)

— 3 Pages are missing (only 1 of the 3 missing pages were sent to Dulberg and may be considered privileged? - Not sure sending the client a Notice is ever considered privileged information.)

— **The 1 common page appears to be identical but is missing the attachment in both (attachment is signified by the paperclip icon next to name in the from portion of the header — This signifies that Flynn sent Julia an attachment in the response that we have never seen. This paperclip icon would not appear if no attachment was sent from Flynn to Williams!)**

— There is one blank page and the original email sent to Flynn that are missing.

— Sent this to Mr Talarico as soon as I found it. - Missing attachment is the main issue.
