When attempting to dissect Mr Flynn's Filing (Mistitled Report of proceedings CC-Civil - 2017LA000377 - 9_19_2022 - - - REOP - -.pdf) I attempted to use Dulberg Master File\Dulberg Paul Deposition w Exhibits in Legal Mal Case 2020 Feb 19.pdf as a baseline and noticed an issue right off the bat.

Mr Flynn's Exhibit 1 is 11 pages (Pages 38-48 from the Mistitled Report of proceedings CC-Civil - 2017LA000377 - 9_19_2022 - - - REOP - -.pdf)

Julia Williams copy (Dulberg Master File\Dulberg Paul Deposition w Exhibits in Legal Mal Case 2020 Feb 19.pdf) of the Dulberg deposition is screwed up:

Exhibit 1 - Pages 179-188 and 259.

This exhibit is split up in 2 locations, why?

When attempting to locate an accurate copy of the Dulberg deposition in the Dulberg Master File I was unable to do so but did find an email sent to Julia Williams from Esquire with links to download the deposition and exhibits.

I used those file names to do a search in the Dulberg Master File and couldn't find them so I expanded the search to my own files and located 18 of the 21 files Esquire sent a link to, only issue is my copy of the files downloaded are missing the following 3 files and I am not sure why:

PTX - 5216936 Dulberg.Paul 021920.ptx (Missing)

ASCII - 5216936 Dulberg.Paul 021920.txt (Missing)

Amicus - 5216936 Dulberg.Paul 021920_AMICUS.txt (missing)

I then went to my email and did another search to see how I got them.

It turns out that Julia Williams forwarded me the Court Reporters email with the links to download the files on March 16, 2020.

It appears Julia Williams recreated the Dulberg deposition found in the Dulberg Master File, screwed it up, and didn't keep the original files provided by Esquire.

I don't know if you have the original Dulberg deposition as it was provided from Esquire so I am attaching to this email all of the files I downloaded from the links Esquire provided.

I hope this works.

There should be 18 files attached.

If not I can break them into smaller groups and resend.

I cannot believe the Clinton firm can't even download and keep the copies from Esquire accurately or keep the exhibit pages together in their recreation.

When I call later today we can discuss whether or not anything from the Clinton Firm is trustworthy and any other issues I may run across between now and then.
