If you already provided this information to us then please point to the documents or emails in the links provided that you sent us and which contain the information we need to comply in detail with the instructions of the clerk.

If you do not keep any notes of your many telephone exchanges with the clerk that you can provide us, this means we are completely dependent on your memory of what the clerk told you. Obviously we need those memories written down and sent to us so we can comply with the instructions of the clerk. Could you please write down everything that you remember from your telephone exchanges with the clerk so we can have this information, too?
