Please find attached my Corrected Proposed Order and Order with an amended briefing schedule.

I was not able to attend Court on July 31, 2023 because of a personal emergency about which I had contacted each lead counsel for the various Defendants on July 28, 2023 and explained the underlying series of events that I did not want to put into a filed motion based upon the sensitivity of the personal emergency.
