I apologize for you not receiving our reply to your February 6, 2024 letters.

Today it was pointed out to me that I have misspelled your name.

As you can see by the forwarded email below, I have been misspelling your name for some time and receiving mailer daemons back.

I have made numerous attempts to contact you by email, phone and US Postal to no avail.

On February 6, 2024 you sent a letter to Paul Dulberg and Richard Kost regarding the refund of a \$2,250 unused balance of a retainer regarding Dulberg v Popovich 17LA377.

We have never received any expert opinion in the form of a report or otherwise from you or your office on any of the cases (17LA377, 2022L10905) we paid retainers to you through Mr. Talarico.
