A---To help you understand and explain / answer your question-

1-Your previous attorney ,Mr Talarico , engaged me as an Expert Witness in the Baudin case.
2-I then sent him an invoice dated April 12, 2023 for \$5400 which was the amount I requested for a retainer. He paid me directly - see a copy of his check following -
3- I wrote " paid 4-14-2023 " on the invoice , because I received his check in full payment .
4- I was terminated by Mr Talarico, in the Baudin case , before I preformed any work .
5- I then promptly returned the entire amount to Mr Talarico-since he was the person who paid me--- See the copy of my check for \$5400 payable to him.
6- I never performed ANY billable services as an expert witness in that Baudin case- confirmed by the fact I returned all of the retainer to him- because he was the one who paid me.

B---The Baudin case was Totally different from the Popovich Case in at least two ways;

1- I performed no services in Baudin after I received the initial retainer ..I performed services in the Popovich case as previously described in invoices .

2- I promptly returned the money to the person who paid me - Mr Talarico in the Baudin case when I was terminated.
I have been waiting to hear from you since February 6, 2024 - for information from you and Richard Kost , to promptly return the unused portion of the retainer I received from Richard Kost in the Popovich Case to the proper party. During that time , unfortunately, Richard Kost passed away..
As you have seen in the invoices and time provided to you, I earned and was paid \$4650 for my services leaving a balance of \$2550 in the retainer - to be promptly returned to the proper party in the Popovich case.

I hope that explains your misunderstanding of the work you think I performed or work you think I did not perform.

So I still do not know why you think I should not be paid for the services as an Expert witness that I performed in the Popovich case .

Please note and I hope you understand the role of an expert witness . I was engaged as an Expert Witness to provide an independent opinion in these two cases.
I was not- and never have been , your lawyer - and do not now nor ever have represented you .
