MOTION TO QUASH SERVICE OF PROCESS

NOW COME defendants, ALPHONSE TALARICO and LAW OFFICE OF ALPHONSE A. TALARICO, by and through their attorneys, STUDNICKA & POULAKIDAS, LLC, pursuant to Section 2-301 of the Illinois Code of Civil Procedure and move to quash putative service of Plaintiff's Complaint at Law. In support thereof, defendants state as follows:

1. Plaintiff Paul Dulburg has provided putative affidavits of service as to Alphonse Talarico and Law Office of Alphonse A. Talarico indicating that a summons was left by the Cook County Sheriff's Office for each defendant with a woman named Deborah Su on December 11, 2025 at 707 Skokie Blvd., Suite 600 in Northbrook, Illinois. *Group Exhibit 1.*

2. Deborah Su is not an employee, officer, associate, registered agent, relative, or otherwise authorized to accept service of process on behalf of Alphonse Talarico or the Law Office of Alphonse A. Talarico. *Exhibit 2.*

3. Alphonse Talarico, individually, has never resided at or made 707 Skokie Blvd., Suite 600 in Northbrook, Illinois his usual abode. *Exhibit 2.*

4. The building located at 707 Skokie Blvd. in Northbrook, Illinois is a multi-story office center and, upon information and belief, Suite 600 is a shared office space operated by Regus. *Exhibit 2*.

5. Leaving a copy of the summons and complaint with Deborah Su at this shared office space does not constitute proper service on the Law Office of Alphonse A. Talarico.

6. Generally, service on a corporation can be accomplished by leaving a copy with the registered agent or officer of the corporation or an agent with “actual authority to accept service on behalf of the corporation.” (735 ILCS 5/2-204) (from Ch. 110, par. 2-204)

7. If Ms. Su was an employee, the court might look further to determine whether she had authority to accept service and ask whether the employee was specifically designated to accept service on behalf of the company, was trained on what to do if served with process, and what was actually done with the summons/complaint after the putative service. *Dei v. Tumara Food Mart Inc.*, 406 Ill.App.3d 856, 941 N.E.2d 920, 347 Ill.Dec. 51 (1st Dist. 2010).

8. Here, Ms. Su is not an employee nor agent of Mr. Talarico or the Law Office of Alphonse A. Talarico and was never given authority to accept service of process for either. *Exhibit 2*.

9. When a corporation is sued, a sheriff's return as to the fact of agency is not conclusive, and for service of process on a corporation to be effectively made upon an agent of defendant, such agent must have actual authority to accept service on behalf of the corporation. *Island Terrace Apartments v. Keystone Service Co., Division of Cole Coin Operated Laundry Equipment, Inc. (Keystone-Cole)*, 341 N.E.2d 41, 35 Ill.App.3d 95, 98 (1st Dist. 1975); *Slates v. International House of Pancakes, Inc.*, 90 Ill.App.3d 716, 728, 46 Ill.Dec. 17, 413 N.E.2d 457 (4th Dist. 1980). See also *Knapp v. Bulun*, 392 Ill.App.3d 1018 1030, 331 Ill.Dec. 720, 911 N.E.2d 541 (1st Dist. 2009) (holding that service on a paralegal who worked for a corporate

defendant's registered agent did not constitute proper service on the corporation because she was not designated as an agent to receive process).

10. Accordingly, the Law Office of Alphonse A. Talarico was not served properly and service of process should be quashed.

11. Generally, an individual can be served by (1) by leaving a copy of the summons with the defendant personally, (2) by leaving a copy at the defendant's usual place of abode, with some person of the family or a person residing there, of the age of 13 years or upwards, and informing that person of the contents of the summons, provided the officer or other person making service shall also send a copy of the summons in a sealed envelope with postage fully prepaid, addressed to the defendant at his or her usual place of abode, or (3) as provided in Section 1-2-9.2 of the Illinois Municipal Code with respect to violation of an ordinance governing parking or standing of vehicles in cities with a population over 500,000. (735 ILCS 5/2-203) (from Ch. 110, par. 2-203).

12. Defendant Alphonse Talarico was not served personally. *Exhibit 2.*

13. Ms. Su is not a family member related to Mr. Talarico and Ms. Su does not reside with Mr. Talarico at 707 Skokie Blvd. in Northbrook, Illinois or at any other address or abode. *Exhibit 2.*

14. Accordingly, Alphonse Talarico, individual, was not served properly and service of process should be quashed.

WHEREFORE, defendants, ALPHONSE TALARICO and LAW OFFICE OF ALPHONSE A. TALARICO, pray that this Court enter an order quashing the service of process as to ALPHONSE TALARICO and LAW OFFICE OF ALPHONSE A. TALARICO, and further for any additional relief that this Court deems just.

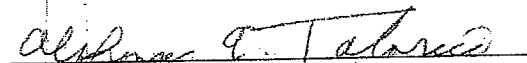
