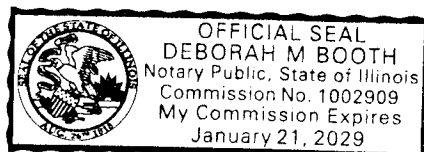
2/23/2026 2:55 pm Spoke with neighbor who confirmed "Al" resides, and indicated the black Lexus in
