Good Morning Paul,

The June 5 date is moving forward. Attorney George Flynn will be present in person. I will appear via phone (CourtCall).


You may appear in person if you wish. You must wear a mask in the courthouse and they may be limiting the number of litigants, but you should be permitted to enter for your own status date.

Alternatively, you may wish to appear telephonically via CourtCall in an effort to avoid the crowd at the courthouse. You should be okay to schedule today if you want. You will need to set up a CourtCall account, but it is fairly simple and there is a modest fee of around \$45 per appearance.

CourtCall Appearances

For those wishing to appear for Court telephonically, please schedule your CourtCall appearance by calling 1-888-882-6878 , or by going to their website [CourtCall.com](https://www.courtcall.com).

Appearances must be scheduled 48 hours in advance.

Status of Case:

The next step is to take Hans Mast deposition. We originally were shooting for June 17, but I now have a conflict, so we are shooting for **June 25 at 10am**. It will be a remote deposition whereby we will all appear through an online application through the court report. More details to come on that. The deposition will not be recorded via video but will have the traditional transcript.

Let me know if that date works for you. We can plan to "meet" likely via video conference prior to that date to discuss documents and deposition questions. We can tentatively plan for June 23 at 2pm. I am fairly flexible early that week so let me know if that date/time doesn't work and we'll find a date/time that works.
