The release usually has this kind of language to make sure that they are held harmless from anyone coming after them for bills not being paid. I am not aware of any other liens on this case, which is what "must" be paid from the settlement. The only claims that attach to his settlement funds are properly executed liens, which I have provided to you. The adjuster advised that she has no liens on this file. Furthermore, it is irrelevant that Allstate states that we are agreeing that all medical providers are paid from the settlement funds because the only ones that we are obligated to pay have executed liens. Accordingly, this boilerplate language appears to be just that and if we want to receive payment on this case, Allstate will require us to sign it. If you are in agreement, please sign and return this at your earliest convenience as I believe the adjuster leaves the office for the holiday on Thursday and we would like to get the check to you as soon as possible so that everything is ready for distribution at the time of the bankruptcy hearing.
