

Regarding payments made by the bankruptcy estate, we obtained the figures regarding the prior attorney's costs from a document entitled, "Release of Client Trust Account Funds (03/23/2015)", prepared by the Popovich office. In that document, it indicates the total amount of costs incurred were \$3,078.64. Furthermore, we were given a printout of Balke's office's client trust ledger sheet, indicating that on 03/20/15 Balke's office reimbursed Popovich's office 50% of the costs incurred (or \$1,539.32) of the total \$3,078.64 costs advanced. We also attach a copy of the Release of Lien from the Popovich office.
