No.</p> <p>8 Q. So you never used a chain saw?</p> <p>9 A. No.</p> <p>10 Q. Okay. Although we have a chain saw here on</p> <p>11 the table that I am understanding you and Carolyn</p> <p>12 purchased --</p> <p>13 A. Correct.</p> <p>14 Q. -- the same year as Paul's accident at your</p> <p>15 house?</p> <p>16 A. Yes.</p> <p>17 Q. Okay. And I might be wrong but I am taking</p> <p>18 this from what Carolyn said but Carolyn said that</p> <p>19 sometime early 2011 before Paul's June 2011 accident</p> <p>20 you two purchased this chain saw that's here on the</p> <p>21 desk today?</p> <p>22 A. Yes.</p> <p>23 Q. And it's a red bodied chain saw and it's a</p> <p>24 gas chain saw, correct?</p> <p style="text-align: right;">7</p>

So you are not able to do heavy type</p> <p>22 work; is that correct?</p> <p>23 A. No.</p> <p>24 Q. Is that correct?</p> <p style="text-align: right;">6</p>	<p>1 A. Yes.</p> <p>2 Q. From Efco, E-F-C-O, MT, 3500. That's what I</p> <p>3 am reading off of it; is that right?</p> <p>4 A. Yes.</p> <p>5 Q. Yes?</p> <p>6 A. Yes.</p> <p>7 Q. Okay. Who purchased it?</p> <p>8 A. I did.</p> <p>9 Q. Okay. Where did you purchase it from?</p> <p>10 A. Menards.</p> <p>11 Q. And since you have never used the chain saw</p> <p>12 before and I am assuming because of your injury you</p> <p>13 weren't planning on using this one, why did you</p> <p>14 purchase it?</p> <p>15 A. Well, I was wondering if we had a storm come</p> <p>16 through and some trees come down I would learn how to</p> <p>17 use it. I am a carpenter.</p> <p>18 Q. Okay.</p> <p>19 A. And I pick up things very quick but if I</p> <p>20 don't have to use it, I don't want to use it.</p> <p>21 Q. Okay. So you got it in case?</p> <p>22 A. Emergency, correct.</p> <p>23 Q. Okay. And you got it for your use, not</p> <p>24 anybody else's?</p> <p style="text-align: right;">8</p>

<p>1 A. Yes.</p> <p>2 Q. For yours, I mean, you physically?</p> <p>3 A. Personally. Personally in case we have trees</p> <p>4 come down or any of that problems.</p> <p>5 Q. But for you to use, correct? Not for you to</p> <p>6 have somebody else use. You got it for you to use; is</p> <p>7 that correct?</p> <p>8 A. Basically I bought it if one of the kids</p> <p>9 wanted to borrow it, I would let them borrow it.</p> <p>10 Q. I understand the options there, but I am</p> <p>11 asking the reason you bought it is for you to use, not</p> <p>12 somebody else to use?</p> <p>13 A. Yes.</p> <p>14 Q. There is options, anybody can use it. I get</p> <p>15 that.</p> <p>16 A. Yes.</p> <p>17 Q. But you bought it for yourself to use,</p> <p>18 though, correct?</p> <p>19 A. Yes.</p> <p>20 Q. All right. How long have you known Paul</p> <p>21 Dulberg?</p> <p>22 A. I probably met him in the '80s because David</p> <p>23 and him were probably friends and, you know, kids come</p> <p>24 over and come and go and that's probably when I ran</p> <p style="text-align: right;">9</p>	<p>1 A. You know, probably -- I believe it was. I</p> <p>2 believe it was.</p> <p>3 Q. Carolyn seemed to think the apple tree</p> <p>4 cutting was sometime in May of that year.</p> <p>5 A. You know, she was probably right. It was</p> <p>6 before the pine tree.</p> <p>7 Q. The evergreens or --</p> <p>8 A. Well, I call them evergreen, pine tree.</p> <p>9 Q. Same thing. Right. Before Paul's accident?</p> <p>10 A. Yes.</p> <p>11 Q. Right. Okay. So according to you, sometime</p> <p>12 in May 2011 when the apple tree was being cut down by</p> <p>13 Dave, Paul was also there to help and he used it to</p> <p>14 cut the stump?</p> <p>15 A. The stump, the tree stump.</p> <p>16 Q. Down lower?</p> <p>17 A. Yes.</p> <p>18 Q. Okay. And that's the only time -- So the</p> <p>19 only time you ever saw Paul use a chain saw before his</p> <p>20 accident in June 2011 was the one time at your house</p> <p>21 when he cut the stump off that apple tree?</p> <p>22 A. Yes. He got the stump lower to the ground.</p> <p>23 Q. Is that true? What I just said, is that</p> <p>24 true? I will say it again because you interrupted me</p> <p style="text-align: right;">11</p>
<p>1 across him the first time.</p> <p>2 Q. All right. Before -- I think Paul's chain</p> <p>3 saw accident at your house was sometime June 2011; is</p> <p>4 that your understanding?</p> <p>5 A. Yeah.</p> <p>6 Q. Okay. Did you know Paul to ever use a chain</p> <p>7 saw before his injury at your house in 2011?</p> <p>8 A. Yes. He was on the property and David used</p> <p>9 the chain saw.</p> <p>10 Q. Are we talking the day of his accident?</p> <p>11 A. This is prior.</p> <p>12 Q. Okay. Go ahead.</p> <p>13 A. Because you were asking if Paul -- I ever saw</p> <p>14 him operate a chain saw.</p> <p>15 Q. You are right.</p> <p>16 A. And he was at the house. David cut down an</p> <p>17 apple tree in the backyard and I saw Paul use the chain</p> <p>18 saw on an apple -- the stump, the apple stump, to try</p> <p>19 to get it closer to the ground. That's the only time I</p> <p>20 ever seen him use the chain saw.</p> <p>21 Q. Fair enough. Was that in the same year of</p> <p>22 his accident at your house?</p> <p>23 A. That was prior.</p> <p>24 Q. Same year, though?</p> <p style="text-align: right;">10</p>	<p>1 by adding on. Let's just answer what my question is.</p> <p>2 Okay. My question is: The only time</p> <p>3 you ever seen Paul use a chain saw before his accident</p> <p>4 at your house in June 2011 was when he cut the stump</p> <p>5 down a little bit lower from the apple tree that was</p> <p>6 at your house in May of 2011?</p> <p>7 A. Yes. The one David Gagnon cut down and he</p> <p>8 got the stump down lower, yes.</p> <p>9 Q. Is what I just said true?</p> <p>10 A. Yes. Yes.</p> <p>11 Q. All right. Because you keep adding. Just</p> <p>12 answer -- If you don't understand my question, I will</p> <p>13 reword it, but try to answer what I am asking instead</p> <p>14 of adding on to what my question is, all right?</p> <p>15 A. Okay.</p> <p>16 Q. Got me?</p> <p>17 A. Yeah.</p> <p>18 Q. Did you see Paul doing anything with the use</p> <p>19 of the chain saw that you thought dangerous or unsafe</p> <p>20 before his accident?</p> <p>21 A. No.</p> <p>22 Q. Did you know that Paul -- and I'm not sure he</p> <p>23 was but I have to ask you. On the day of Paul's</p> <p>24 injury at your house in June 2011, you know, with Dave</p> <p style="text-align: right;">12</p>

<p>1 there, do you know if Paul was ever even using the</p> <p>2 chain saw that day?</p> <p>3 A. No.</p> <p>4 Q. Do you know? You don't know?</p> <p>5 A. I don't know if he was using the chain saw.</p> <p>6 Q. That's what I am asking. Okay. Let me ask</p> <p>7 you a couple questions and today -- Well, let me ask</p> <p>8 it this way: When is the last time you spoke or saw</p> <p>9 Paul?</p> <p>10 A. Probably three weeks ago in a grocery store.</p> <p>11 Q. Did you speak to him or just see him?</p> <p>12 A. Said hi.</p> <p>13 Q. Did he say hi to you?</p> <p>14 A. Yes.</p> <p>15 Q. Was that it?</p> <p>16 A. Correct.</p> <p>17 Q. Did you see him carrying anything?</p> <p>18 A. No.</p> <p>19 Q. Okay. Did you see him do anything that would</p> <p>20 suggest he wasn't having problems with his arm that he</p> <p>21 cut in this chain saw accident at your house in 2011?</p> <p>22 A. I did not see him doing anything but walking</p> <p>23 with his mother.</p> <p>24 Q. Okay. Before Paul's accident in June 2011 at</p> <p style="text-align: right;">13</p>	<p>1 honest. Okay. Why do you think he is a fibber?</p> <p>2 A. You know, it should be cut and dry. I mean,</p> <p>3 it was an accident.</p> <p>4 Q. Right. All right.</p> <p>5 A. And that's all I know.</p> <p>6 Q. Is it -- So I am reading into this, you can</p> <p>7 tell me if I am wrong, but is it because a lawsuit was</p> <p>8 filed; is that why?</p> <p>9 A. Duh. Yes.</p> <p>10 Q. Well, listen, I have to ask these questions,</p> <p>11 sir. Let me just go through this and make it easy for</p> <p>12 me, all right?</p> <p>13 A. I'm sorry. Yes.</p> <p>14 Q. You are making it hard. The fact that a</p> <p>15 lawsuit was filed and you are part of that lawsuit has</p> <p>16 that made you feel that he is a fibber?</p> <p>17 A. Well --</p> <p>18 Q. Or I am trying to find out.</p> <p>19 A. Basically, since the lawsuit was filed and,</p> <p>20 you know, it wasn't cut and dry, I just probably don't</p> <p>21 want nothing to do with him now, so.</p> <p>22 Q. Okay. So let me -- again, I have -- because</p> <p>23 some of the words you have used, I have to ask you</p> <p>24 about it. Do you feel he is a fibber or you just</p> <p style="text-align: right;">15</p>
<p>1 your house, were -- did you consider him a friend,</p> <p>2 just a friend of your stepson's? How did you -- What</p> <p>3 was his status with you?</p> <p>4 A. I considered him a friend of my stepson.</p> <p>5 Q. Okay. So more of an acquaintance to you</p> <p>6 then? He wasn't somebody you'd socialize with outside</p> <p>7 of your son or something then?</p> <p>8 A. Correct. If he wasn't around for my son, he</p> <p>9 didn't come around.</p> <p>10 Q. So he wasn't like your buddy or anything?</p> <p>11 A. No. No.</p> <p>12 Q. Okay. So you were on good terms with him</p> <p>13 because he was obviously on good terms with your son</p> <p>14 before this accident occurred, right?</p> <p>15 A. Yes.</p> <p>16 Q. Did that change at all at least in your mind?</p> <p>17 Now Dave has spoken his peace so we don't even need to</p> <p>18 go into what Dave thinks, but in your mind has your</p> <p>19 feelings about Paul changed today versus before his</p> <p>20 injury at your house?</p> <p>21 A. Yes.</p> <p>22 Q. Okay. Good, bad, indifferent, what?</p> <p>23 A. Well, I think he is a fibber.</p> <p>24 Q. Okay. Fair enough. You are just being</p> <p style="text-align: right;">14</p>	<p>1 don't like the fact that he filed a lawsuit against</p> <p>2 you?</p> <p>3 A. I don't like the fact that he filed a</p> <p>4 lawsuit.</p> <p>5 Q. Okay. So fibber meaning liar, you are not</p> <p>6 calling him a liar?</p> <p>7 A. No. No. No. I'm sorry. Just because he</p> <p>8 filed a lawsuit.</p> <p>9 Q. All right. So let me -- Again, I got to</p> <p>10 clear that up now. Do you believe in your mind that</p> <p>11 Paul is a fibber or a liar or don't you know?</p> <p>12 A. I don't know.</p> <p>13 Q. Okay. And I meant more about this lawsuit</p> <p>14 obviously. You don't know if he is lying or fibbing</p> <p>15 about the lawsuit because you don't know what</p> <p>16 happened, right?</p> <p>17 A. Yes.</p> <p>18 Q. Fair enough?</p> <p>19 A. Yes.</p> <p>20 Q. <p>1 June 2011, did you believe Paul was a credible, honest</p> <p>2 soul, person?</p> <p>3 A. Yes.</p> <p>4 Q. Okay. Did you have any reason to believe</p> <p>5 that he would fib prior to this accident?</p> <p>6 A. No.</p> <p>7 Q. Okay. All right. Have you heard -- Well,</p> <p>8 let me put Dave aside for a minute. Other than</p> <p>9 through Dave, have you heard that Paul was trying to</p> <p>10 make more out of this accident than was warranted</p> <p>11 other than -- I'm sorry. Let me --</p> <p>12 MR. BARCH: Other than David or his attorney.</p> <p>13 BY MR. MAST:</p> <p>14 Q. Yeah. Other than through Dave or Dave's</p> <p>15 attorney or your attorney I guess, have you heard</p> <p>16 either from Paul or anybody else --</p> <p>17 A. No.</p> <p>18 Q. -- something to the effect that Paul was</p> <p>19 trying to make more out of this claim or accident than</p> <p>20 he should?</p> <p>21 A. I have not heard nothing, no.</p> <p>22 Q. Okay. So I just want to make one</p> <p>6 other question on that just to make sure I covered</p> <p>7 everything.</p> <p>8 Is it fair to say then other than maybe</p> <p>9 through your attorney you have never heard any</p> <p>10 allegation or suggestion whether by Paul or anybody</p> <p>11 else, Dave, Paul, anybody, that Paul was trying to</p> <p>12 make more out of this case than was justified and/or</p> <p>13 trying to get people to talk in favor of him in return</p> <p>14 for anything? Have you ever heard those things?</p> <p>15 A. Other than David's comments or maybe my</p> <p>16 attorney a little bit, I haven't heard nobody else say</p> <p>17 a word.</p> <p>18 Q. Okay. Including Paul, correct?</p> <p>19 A. Oh, yeah.</p> <p>20 Q. Okay. So what did Dave tell you in that</p> <p>21 regard?</p> <p>22 A. Dave was saying that somehow the accident</p> <p>23 happened different than when the way Paul was</p> <p>24 describing it.</p> <p style="text-align: right;">19</p>
<p>1 A. No.</p> <p>2 Q. Have you ever heard Paul since his accident</p> <p>3 or anybody -- Strike that.</p> <p>4 Have you ever heard Paul since his</p> <p>5 accident ever suggest that he may never have to work</p> <p>6 again in his life or he is going to be able to be rich</p> <p>7 or anything like that, those issues, since this</p> <p>8 accident?</p> <p>9 A. No.</p> <p>10 Q. Okay. Have you heard those through Dave?</p> <p>11 A. No.</p> <p>12 Q. Dave has not even told you those things that</p> <p>13 Paul has said supposedly?</p> <p>14 A. David has told me that he is not telling the</p> <p>15 truth.</p> <p>16 Q. Okay.</p> <p>17 A. That's what he told me.</p> <p>18 Q. All right. So Dave told you Paul is not</p> <p>19 telling the truth about the accident.</p> <p>20 A. Correct.</p> <p>21 Q. But has Dave ever told you since the accident</p> <p>22 that Paul was trying to get him to lie or get him to</p> <p>23 say things so that they can retire?</p> <p>24 A. Dave --</p> <p style="text-align: right;">18</p>	<p>1 Q. Okay. And that's not quite what I asked so</p> <p>2 let me go back because we are going to get into that.</p> <p>3 Okay.</p> <p>4 Let me -- My question was framed more to</p> <p>5 other than your attorney, have you heard from anyone</p> <p>6 including Paul, including Dave, anyone, that Paul was</p> <p>7 trying to get people to fabricate or lie to his favor</p> <p>8 in this case or to help him recover in this case?</p> <p>9 A. No. Nobody told me that.</p> <p>10 Q. Not Dave, not Paul, nobody, right?</p> <p>11 A. The only thing I am saying is the question</p> <p>12 you are asking me is the same question I am saying is</p> <p>13 if it's got to pertain to the accident, David didn't</p> <p>14 agree with the way Paul stated the accident happened.</p> <p>15 Other than that --</p> <p>16 Q. And I understand there is two versions of the</p> <p>17 accident. I understand that.</p> <p>18 A. Correct.</p> <p>19 Q. My question was different, though. My</p> <p>20 question was: Have you ever heard, other than through</p> <p>21 your attorney, that either Paul or Dave suggested that</p> <p>22 Paul was wanting people to lie for him or to fabricate</p> <p>23 anything?</p> <p>24 A. Other than Dave and my attorney, no. Nobody</p> <p style="text-align: right;">20</p>

<p>1 has told me anything about --</p> <p>2 Q. I am including Dave in that. What did Dave</p> <p>3 tell you about Paul wanting him to fabricate or lie?</p> <p>4 Did he say that?</p> <p>5 A. As far as Paul telling David to change the</p> <p>6 story or fabricate?</p> <p>7 Q. Yeah. Did he do that?</p> <p>8 A. David never mentioned it to me like that, no.</p> <p>9 Q. Okay. So all right. So let me say the</p> <p>10 question again then. Is it fair to say, and putting</p> <p>11 your attorney's comments to you aside, okay, I am not</p> <p>12 asking you about your attorneys, but with regard to</p> <p>13 anybody else, you have never heard anyone suggest that</p> <p>14 Paul was trying to get Dave to lie, fabricate about</p> <p>15 this case, fair enough?</p> <p>16 A. Yeah.</p> <p>17 Q. Okay. You never heard that?</p> <p>18 A. No.</p> <p>19 Q. All right. As I understand it, there are two</p> <p>20 evergreens in your backyard back in June 2011 that you</p> <p>21 guys wanted cut down so you could put a storage shed</p> <p>22 back there, right?</p> <p>23 A. Yes.</p> <p>24 Q. Okay. And as I understand it, I don't</p> <p style="text-align: right;">21</p>	<p>1 A. Uh-huh.</p> <p>2 Q. All right. So whatever the arrangement was</p> <p>3 between Carolyn and Dave as far as what he would get</p> <p>4 in return for doing this work, you don't know; fair</p> <p>5 enough?</p> <p>6 A. Yes.</p> <p>7 Q. Okay. And what was Dave's experience, if you</p> <p>8 know, in use of a chain saw before this accident with</p> <p>9 Paul at your house?</p> <p>10 A. Stuff I have heard, a project he worked on</p> <p>11 through the course of me living there and physically</p> <p>12 seeing him prune the trees on the property with a chain</p> <p>13 saw.</p> <p>14 Q. Okay.</p> <p>15 A. That's about the extent of it.</p> <p>16 Q. With a chain saw?</p> <p>17 A. Correct.</p> <p>18 Q. With your chain saw?</p> <p>19 A. No. We didn't have it then.</p> <p>20 Q. Okay. With his chain saw on his property?</p> <p>21 A. No. Back when David lived at the house.</p> <p>22 Q. With you?</p> <p>23 A. On our property when David lived there --</p> <p>24 Q. Right.</p> <p style="text-align: right;">23</p>
<p>1 remember if it was you or your wife, but one of you</p> <p>2 asked Dave to do that work -- help with that work,</p> <p>3 right?</p> <p>4 A. Yeah. Knock some lower branches down.</p> <p>5 Q. Right. Who asked him to do that?</p> <p>6 A. You know, I don't remember.</p> <p>7 Q. Okay. It was either you or your wife?</p> <p>8 A. Correct.</p> <p>9 Q. And I think your wife said she was going to</p> <p>10 pay Dave something for his gas or whatever, right?</p> <p>11 A. Basically, she'd give him a pair of pants. I</p> <p>12 don't know. They are always mothering the son, you</p> <p>13 know.</p> <p>14 Q. Right. So what their arrangement was as far</p> <p>15 as money or --</p> <p>16 A. Some kind of gift.</p> <p>17 Q. Listen, you are going to make this last twice</p> <p>18 as long as -- I'd like to get you in and out of here</p> <p>19 as quick as possible but because I have to keep</p> <p>20 repeating the question, it's going to make it</p> <p>21 difficult so I am just trying to tell you we can</p> <p>22 probably get out of here real quick but I am going to</p> <p>23 have to keep backing up. So let me try to move</p> <p>24 forward but let me finish my question, okay?</p> <p style="text-align: right;">22</p>	<p>1 A. -- I don't know where he got the chain saw</p> <p>2 but he had a chain saw and he done some pruning on the</p> <p>3 property and that I have seen him do.</p> <p>4 Q. Okay. Okay. And how often was that? Just</p> <p>5 the one time or was it repeatedly?</p> <p>6 A. I would say a handful of times.</p> <p>7 Q. Okay. Over the course of several years?</p> <p>8 A. Yeah. In 2011 other than the two evergreen</p> <p>22 trees he was going to take some of the branches down</p> <p>23 off of, did he do -- did Dave do any other work with</p> <p>24 the chain saw on your property in that year?</p> <p style="text-align: right;">24</p>

<p>1 A. Cut the apple tree down.</p> <p>2 Q. Okay. Anything else?</p> <p>3 A. No.</p> <p>4 Q. Okay.</p> <p>5 A. You know, he did a little chain saw work.</p> <p>6 No. That was about it. That was about it that I</p> <p>7 remember.</p> <p>8 Q. Okay. So the apple tree and the two</p> <p>9 evergreens, those are the only chain saw work he was</p> <p>10 doing at your house in 2011, correct?</p> <p>11 A. That I remember. You know, I'm trying to</p> <p>12 remember because I know Paul took some scrap from the</p> <p>13 front yard from a maple tree.</p> <p>14 Q. Yeah. Your wife said just to --</p> <p>15 A. And --</p> <p>16 Q. Go ahead.</p> <p>17 A. And I don't remember if he used the chain saw</p> <p>18 to cut them pieces up a little further but I don't</p> <p>19 remember that.</p> <p>20 Q. What your wife said was a tree company took</p> <p>21 that tree down.</p> <p>22 A. Yes, they did.</p> <p>23 Q. Let me finish. And left some stumps or</p> <p>24 sections and Paul and Dave cut those sections up so</p> <p style="text-align: right;">25</p>	<p>1 A. Watching TV.</p> <p>2 Q. Okay. Was that -- Do you know about what</p> <p>3 time Paul's accident occurred that day?</p> <p>4 A. I don't remember.</p> <p>5 Q. If you were watching TV when his accident</p> <p>6 occurred, would that have been pretty much what you</p> <p>7 were doing for most of the day prior to leading up to</p> <p>8 his accident or were you doing other things in the</p> <p>9 house?</p> <p>10 A. I was in the house. I am trying to</p> <p>11 remember -- I might have walked around a little bit,</p> <p>12 you know, and then I was in the house.</p> <p>13 Q. Did you ever go outside the house while Paul</p> <p>14 and Dave were in the backyard working?</p> <p>15 A. No.</p> <p>16 Q. So would it be fair to say that day of Paul's</p> <p>17 accident before his injury, you don't know who was</p> <p>18 doing what type of work, where, when or how?</p> <p>19 A. That's true.</p> <p>20 Q. Okay. And you never viewed at any time prior</p> <p>21 to Paul's injury what they were doing back there in</p> <p>22 the backyard, correct?</p> <p>23 A. That's correct.</p> <p>24 Q. Do you know what -- I know that you said Dave</p> <p style="text-align: right;">27</p>
<p>1 Paul could have firewood. That's what she said.</p> <p>2 A. I --</p> <p>3 Q. You don't know?</p> <p>4 A. I know Paul took the wood, the bulk of the</p> <p>5 wood.</p> <p>6 Q. Who cut it up, you don't know?</p> <p>7 A. No.</p> <p>8 Q. Okay. Yes.</p> <p>13 Q. Okay. I think Paul's accident was June 28,</p> <p>14 2011. Do you know that to be true or not?</p> <p>15 A. You know, it sounds -- but I don't know.</p> <p>16 Q. Do you know what day of the week it was?</p> <p>17 A. No.</p> <p>18 Q. Okay. You were retired so you would have not</p> <p>19 been working. Would you have been home at the time?</p> <p>20 A. Yes.</p> <p>21 Q. What were you doing at the time of Paul's</p> <p>22 injury?</p> <p>23 A. I was in the house.</p> <p>24 Q. Doing what?</p> <p style="text-align: right;">26</p>	<p>1 was going to cut down some limbs from the two</p> <p>2 evergreens, right?</p> <p>3 A. Yes.</p> <p>4 Q. And I think Carolyn then said ultimately once</p> <p>5 the limbs were down, you were going to have the tree</p> <p>6 company come out and cut the big base of the tree</p> <p>7 down, right?</p> <p>8 A. Yes.</p> <p>9 Q. So Dave's task was really just to take the</p> <p>10 branches off the base of the tree, right?</p> <p>11 A. Yeah.</p> <p>12 Q. All the way up?</p> <p>13 A. How wide -- if you have an estimate, how wide</p> <p>24 are the limbs, the branches, coming off the evergreens</p> <p style="text-align: right;">28</p>

<p>1 at the bottom of the trees?</p> <p>2 A. Oh, they had to be -- in the base of it had</p> <p>3 to be, I don't know, four or five feet, something like</p> <p>4 that.</p> <p>5 Q. <p>1 Q. And did you know Paul was coming over to help</p> <p>2 out?</p> <p>3 A. No.</p> <p>4 Q. Did you know who invited him over?</p> <p>5 A. No.</p> <p>6 Q. Okay. Did you even know he was on your</p> <p>7 property when --</p> <p>8 A. Yes.</p> <p>9 Q. Let me finish the question. Did you even</p> <p>10 know Paul was on your property by the time he got</p> <p>11 hurt?</p> <p>12 A. Yes.</p> <p>13 Q. How did you know he was on the property?</p> <p>14 A. 18 while they were working that day?

19 A. She might have -- Go ahead.

20 Q. Did you know if your wife was ever outside

21 that day of Paul's injury before his injury?

22 A. I don't keep track of her.

23 Q. So the answer is you don't know?

24 A. I don't know.

2 you met up with them kind of at the rear of the house?

23 I asked David, you know, and Dave says not too good.

24 You know, he says -- weren't in a very talkative mood.
