Click the link that says "Test Center" in blue and then click on "Cameo Test." Join as a participant from your computer (iPad). It will then open zoom (make sure you have it downloaded), then "Join with Video". Once you join with video, six dial in numbers will appear as well as a Meeting ID and Participant ID. A screen shot is attached to show the phone numbers and id numbers. If you are using an iPad, you may have to scroll down to see the meeting id and participant Id. Join the audio portion by calling one of the phone numbers and providing your meeting ID and participant ID when prompted.

Once you have joined with audio and video, you should be all set.

If you still have trouble, on US Legal's website there are a couple of videos that may help you trouble shoot.
